8		discrimination and call for stronger penalties than crimes not involving
9		discrimination; now, therefore, be it
10	RESOLVED,	That the UIL Congress here assembled order that all US states include the
11		same characteristics addressed by federal hate crime laws, including
12		disability and socioeconomic status; and, be it
13	FURTHER RES	<b>SOLVED,</b> That states that refuse to comply with will lose 25% of grants or
14		funds allocated to them by the Office of Justice Programs.

7	SECTION 3.	The Department of Health and Human Services will regulate the organ
8		harvesting, organ preservation, and organ transplant process.
9		A. All surgical procedures involved in the transaction must occur at an
10		accredited medical provider.
11		B. Organ prices will be set by the free market, and the transaction will be
12		a taxable event.
13		C. All organ purchases must be to directly treat an individual's medical
14		condition and not for any alternative purposes.
15	SECTION 4.	Implementation will occur by January 1, 2017.
16	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

### A Bill to Allow Criminal Offenders the Option of Military Service as an Alternative to Jail Time

BE IT ENACTED BY THIS UIL CONGRESS HERE ASSEMBLED THAT: SECTION 1. First time offenders between the ages of 18-25, who have been convicted of a non violent felony offense, will have the opportunity to enlist in the 3 military for a time equal to the jail sentence issued, but not less than one 4 year of military service. 5 SECTION 2. Nonviolent crimes are crimes that do not involve the use of any force or 6 injury to another person. The seriousness of a nonviolent crime is usually 7 measured in terms of economic damage or loss to the victim. 8 SECTION 3. The federal and state judicial systems will oversee the judicial process of 9 the defendant, and the Department of Defense will be responsible for all 10 aspects of the individual's military service. 11 12 A. The full sentence time charged must be met, unless the individual would have qualified for early dismissal due to good behavior. 13 B. Even if the individual is eligible for early dismissal prior to one year of 14 service, they will be required to serve the remainder of that year, but 15 will receive rank-level compensation for the balance in time. 16 SECTION 4. Implementation will occur by January 1, 2017. 17 SECTION 5. All laws in conflict with this legislation are hereby declared null and void. 18

### A Bill to Increase National Education Funding By 10 Billion US Dollars

3		improve the lacking US education system. In 2013 US didn't break into
4		the top 20 list for global education ranking. It is unacceptable that such a
5		resourceful nation, the United States, fails in its education.
6	SECTION 2.	Education for the purpose of this bill is defined as the teaching of math,
7		science, history, or English at any public school or university.
8	SECTION 3.	The use of the money will be overseen by the US Department of
9		Education.

12		equipment, desks, calculators, and practical materials needed for

15		schools in areas lacking schooling or suffering from a school that is
16		not fully functioning.
17	SECTION 4.	This bill will go into effect at the beginning of 2016.
18	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

#### A Bill to Suspend Some Authority of the President

4		related to the nuclear program of Iran.
5	SECTION 2.	Sanctions in this section are any agreement related to the nuclear
6		program of Iran that includes the United States.
7	SECTION 3.	Congress and the Judicial Branch will oversee the execution of this bill to
8		ensure that the President does not overstep his boundaries.

9		frequently under the influence of government-issued narcotics; and
10	WHEREAS,	The government of Zimbabwe illegally sells ivory from endangered
11		elephants to pay for its oppressive government; now, therefore, be it
12	RESOLVED,	That the UIL Congress here assembled recommend that the US pass
13		additional sanctions against Zimbabwe.

### A Bill to Remove Credit Unions Tax Exempt Status

1	BE IT ENACTE	D BY THIS UIL CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1.	Credit unions have become increasingly more like banks, yet they are not
3		required to pay taxes like banks. Credit unions have begun giving money
4		out as loans, like that of a bank loan. So credit unions will receive no tax
5		exemption, and will pay taxes equal to that of banks.
6	SECTION 2.	Credit union is defined as a non-profit making money cooperative whose
7		members can borrow from pooled deposits at low interest rates. Tax
8		exemption is defined as anyone or thing that is free or not subject to
9		taxes by the United States Government.
10	SECTION 3.	The Tax Division of the Department of Justice will oversee the
11		implementation of this bill.
12		A. For if any reason a credit union tries to evade taxes, it will have raised
13		taxes for the remaining fiscal year.
14		B. If a second violation occurs, the union will have permanent raised
15		taxes until the credit union can prove it follows the rules established.
16		C. Credit unions who display honest behavior are capable of receiving
17		tax breaks and or tax cuts from the US Government.
18	SECTION 4.	This bill will go in to effect beginning the year 2016.
19	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

#### A Bill to amend Child Abuse Prevention and Treatment Act to More Effectively Restrict the Use of Force

BE IT ENACTED BY THIS UIL CONGRESS HERE ASSEMBLED THAT:

2	SECTION 1.	Congress will amend CAPTA to include specific language concerning all
3		acts of assault. Because of the insufficient wording in its current
4		definition, parents, teachers and caretakers have ample opportunity in
5		which they are able to mistreat children, yet still remain within the
6		guidelines of the act. The ultimate goal of this amendment is to
7		distinguish between acts of legal corporal punishment and acts of
8		criminal assault.
9	SECTION 2.	CAPTA currently defines child abuse as "any recent act or failure to act on
10		the part of a parent or caretaker which results in death, serious physical
11		or emotional harm, sexual abuse or exploitation or an act or failure to act
12		which presents an imminent risk of serious harm." Assault is "an attempt
13		or threat, with unlawful force, to inflict bodily injury upon another,
14		accompanied by the apparent present ability to give effect to the attempt
15		if not prevented."
16	SECTION 3.	The Department of Health and Human Services will oversee and
17		implement the amendment.
18	SECTION 4.	Implementation will occur by January 1, 2016.
19	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

3		and 25 years will be required to register with Selective Service in the
4		event that our country is at a time of war and implements the draft.
5	SECTION 2.	The draft refers to the compulsory recruitment for military service in
6		times of impending war.
7	SECTION 3.	The Department of Defense and the Selective Service System will enforce
8		the draft registration process.
9		A. Women currently serve in all roles of the military, and this bill is
10		simply an extension of this practice.
11		B. Any service exemptions or forgiveness will be considered and
12		potentially issued at the time in which the individual is called into
13		service.
14	SECTION 4.	Implementation will occur by January 1, 2016.
15	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

12		asylum to Syrian refugees; and, be it
13	FURTHER RES	<b>SOLVED,</b> That the United States government encourage other nations to
14		protect those displaced by this crisis.
