

A Resolution to Reduce Carbon Emissions in the United States

1	WHEREAS,	The United States emits more harmful carbon dioxide into the air than
2		any other country.
3	WHEREAS,	Causing significant drought and harmful levels of carbon emissions
4		forcing climate change; and
5	WHEREAS,	In order to improve air quality and reverse the effects of climate change
6		and global warming;
7	WHEREAS,	The United States would require states to comply with federal CO2
8		emission standards; now , therefore, be it
9	RESOLVED,	That the UIL Congress here assembled creates incentives for trading
10		programs in which companies could buy and sell pollution credits to
11		comply with tightening limits for carbon emissions, and be it
12	FURTHER RES	SOLVED, that the United States could also impose penalties on states for
13		non-compliance in carbon emissions from power plants.

A Bill to Mandate Senior Citizens to Take Mandatory Driving Tests

- 1 BE IT ENACTED BY THIS UIL CONGRESS HERE ASSEMBLED THAT:
- SECTION 1. At age sixty, adults will take mandatory driving tests to renew licenses every four years.
- 4 **SECTION 2**. Each state's Department of Public Safety will be responsible for enforcing the provisions of the bill by sending reminders to adults who qualify for the test.
 - **A.** If adults do not pass the driving test, their license will be suspended for a time period of six months, after which they will take a test to renew their driver's license.
 - B. If an adult fails the driving test three times, their license will be permanently suspended.
- **SECTION 3.** The bill will be implemented starting January 1, 2016.
- **SECTION 4.** All laws in conflict with this legislation are hereby declared null and void.

A Bill concerning ISIS

1	BE IT ENACTE	D BY THIS UIL CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1.	The United States will form a joint terrorism task force with the
3		governments of Syria and surrounding countries in order to eliminate the
4		ISIS terrorism threat.
5	SECTION 2.	The Joint task force will be an assembly of specialized tacticians and
6		workers who formulate a plan to terminate the threat of the terrorist
7		group ISIS through whatever mean deemed necessary by the collective.
8	SECTION 3.	The Department Of Defense will have administrative control of this task
9		force and a representative will be the meeting conductor. Funding for the
10		formation of this task force will be provided by the federal government
11		through an increased tax on alcohol, as well as grants provided by the
12		United States Government.
13	SECTION 4.	This law will take effect beginning February 1 2015 to allow for the
14		allocation of funds and delegation of power.

A Bill to Restrict Private Water Usage in Severe Drought Conditions

- 1 BE IT ENACTED BY THIS UIL CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1**. Private water usage shall be restricted when any US State is in severe
- 3 drought conditions.
- 4 **SECTION 2.** Severe drought shall be defined as water shortage that results in a
- 5 declared state of emergency.
- 6 **SECTION 3.** Private water usage shall be defined as watering lawns, or washing
- vehicles at any private residence.
- 8 **SECTION 4.** Oversight will be through Municipal Water Districts in each state.
- A. Proof of non-compliance will result in fines ranging from \$500 \$1500
- per citation.
- SECTION 5. This bill will go in to effect as of March 1^{st} , 2015.
- **SECTION 6.** All laws in conflict with this legislation are hereby declared null and void.

1	WHEREAS,	in the Status Quo, unregulated immigration throughout Border States,
2		such as Texas and Arizona, continues to grow, and

4		residents in those states; and
5	WHEREAS,	the United States Federal Government must act and implement a policy
6		to regulate and prevent illegal immigration in border states; if this does
7		not happen, the US will continue to harbor millions of illegal residents
8		and the general fiscal burden will continue to widen; and
9	WHEREAS,	the current immigration policy does not address the growing problem
10		caused by years of delay in action by lawmakers; now therefore, be it
11	RESOLVED,	that the UIL Congress here assembled should implement a policy to
12		reduce and effectively control illegal immigration substantially in the US.
13	FURTHER RES	SOLVED, that the United States Congress take immediate action to protect
14		the citizens of these United States.

9	WHEREAS,	Regulating waste from drilling, fracking and processing oil and natural gas
10		is environmentally sound and improves Texas' as the lowest performing
11		state in the nation; now, therefore, be it
12	RESOLVED,	That the UIL Congress here assembled recommend to create a plan to
13		improve standards of toxic chemicals, carbon dioxide emissions and
14		hazardous waste materials in regards to drilling, fracking and processing
15		oil and natural gas;

A Resolution Regarding School Start Times

1	WHEREAS,	Students across the country suffer from a lack of sleep due to early
2		school start times as they are not in sync with students circadian
3		rhythms; and
4	WHEREAS,	Students are sleep deprived and studies suggests that 60% of children
5		under the age of 18 complained of being tired during the day, and 15%
6		said they fell asleep at school during the year. And;
7	WHEREAS,	A lack of sleep threatens students grades, safety, and health. And;
8	WHEREAS,	studies suggest that later school start times equate to fewer instances of
9		depressed moods; reduced likelihood for tardiness; reduced
10		absenteeism; better grades; reduced risk of "drowsy driving"; and
11		reduced risk of metabolic and nutritional deficits associated with
12		insufficient sleep, including obesity. Therefore, be it
13	RESOLVED,	That the UIL Congress here assembled push back school start times by at
14		least 1 hour to help students work at their maximum capability while
15		making them safer and healthier in the process.

A Bill to require Current Events & Issues Classes in U.S. Schools

2	BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

4	SECTION 1. Be it required that students between the grades 9 and 12
5	take at least 2 years of Current Events & Issues classes
6	to promote and ensure education and awareness of their
7	world.
8	
9	SECTION 2. Many students go out into the world unaware of the
10	serious issues that are affecting them and others. Lack of
11	understanding is due to a lack of education and exposure.
12	Well-rounded citizens are the goal of public education.
13	
14	SECTION 3. The enforcement of this bill will be through the U.S. Department of
15	Education.
16 17	A. Funding will be through federal and state taxation through normal means.
18	
19	B. Educators of the subject must have a History, English,
20	Political Science, or Economics certification.

22	SECTION 4. Implementation will begin in the 2015 – 2016 school year.

A Resolution to Increase Safety in US schools by using Student Resource Officers

RESOLVED, That the UIL Congress here assembled make the following recommendation that all schools be required to have Armed Student Resource Officers on school grounds and facilities at all times.

A Resolution to Amend the Constitution to Establish Term Limits for Members of Congress

RESOLVED, By two-thirds of the UIL Congress here assembled, that the following article is proposed as an amendment to the Constitution of the United States, which shall be valid to all intents and purposes as part of the Constitution when ratified by the legislatures of three-fourths of the several states within seven years from the date of its submission by the Congress:

BE IT ENACTED BY THIS UIL CONGRESS HERE ASSEMBLED THAT:

ARTICLE I

SECTION 1: No person who has served four or more terms as a United States Representative shall be eligible for election to the US House of Representatives. If elected by special election to fill a vacancy in the US House of Representatives for a period longer than one year, then that time in office shall be counted as one term.

Section 2: No person who has served two or more terms as a United States Senator shall be eligible for election or appointment to the US Senate. If elected by special election or appointed to fill a vacancy in the US Senate for a period of longer than three years then that time in office shall be counted as one term.

Section 3: Upon ratification of this article, any incumbent member of the United States

Congress whose current term exceeds the term limits shall complete their

current term, but thereafter shall be ineligible for further service as a member of the US Congress.

Section 4: Any laws in conflict with this legislation are hereby declared null and void.

5	WHEREAS,	The system utilizes a winner-take-all method of distributing votes from
6		each state; and
7	WHEREAS,	Under the electoral college system a presidential candidate can win an
8		election without winning a majority of popular votes; now, therefore, be
9		it
10	RESOLVED,	That the UIL Congress here assembled recommend that the Electoral
11		College system be abandoned; and, be it
12	FURTHER RES	SOLVED, That the Electoral College system be replaced with a more
13		efficient and fair system such as the direct voting system.

A Resolution to Require On-Duty Police Officers to Wear Body Cameras

1	WHEREAS,	There is a lack of trust between law enforcement and citizens; and
2	WHEREAS,	The use of video recording technology would allow for an unbiased
3		documentation of interactions between police and citizens; and
4	WHEREAS,	Citizens frequently question the accountability measures taken when
5		police misconduct occurs; and
6	WHEREAS,	Current implementation of police body cameras have seen an overall
7		decrease in use-of-force complaints; and
8	WHEREAS,	Eyewitness testimonies are unreliable and often biased; and
9	WHEREAS,	Video recordings from police body cameras will enhance the
10		department's ability to gather and preserve evidence; now, therefore, be
11		it
12	RESOLVED,	That the UIL Congress here assembled require on-duty police officers to
13		wear body cameras.

A Resolution to Eliminate Restrictions on Food in Schools

1	WHEREAS,	Students' freedoms are being taken away by their inability to choose
2		what they are able to spend their money on; and
3	WHEREAS,	The current stipulations go too far in taking away what can and can't be
4		sold in the schools; and
5	WHEREAS,	School organizations are restricted on what they can and can't sell for
6		fundraisers; and
7	WHEREAS,	Schools can make more money with much more popular choices to
8		choose from; now, therefore, be it
9	RESOLVED,	That the UIL Congress here assembled that we eliminate the restrictions
10		on what food can be served and sold at schools with the exception for
11		students purchasing food on the free and reduced lunch program.

- 3 cubic meters of each of the seventeen rare earth metals.
- 4 **SECTION 2**. A rare earth metal is one of a set of seventeen chemical elements in the
- 5 periodic table as defined by IUPAC.
- 6 **SECTION 3.** The U.S. Bureau of Mines will enforce this bill.
- A. The Bureau of Mines will conduct a study to determine the best
- 8 location for the reserve.
- 9 **SECTION 4.** This bill will come into effect the day after it is passed, and the Reserve
- should be open within 5 years of passage.
- SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A Resolution to enforce the immigration laws of the United States, and significantly reduce illegal immigration

1	WHEREAS,	The United States, a nation of immigrants, cannot sustain the current	
2		rate of illegal immigration and continue to provide its current standard of	
3		living and safety for its citizenry; and	
4	WHEREAS,	schools, social services, medical services, economic development, and the	
5		established way of life, are at risk under the current system; and	
6	WHEREAS,	while these immigrants come to the United States in hopes of finding,	
7		"The American Dream." It is precisely that dream of, "life, liberty, and	
8		the pursuit of happiness," that is in jeopardy for all U. S. citizens; and	
9	WHEREAS,	while assimilation of the hungry and huddled masses is innate to the	
10		democratic experiment known as the United States, "a house divided,	
11		cannot stand." The rate of current immigration exceeds the ability of the	
12		U. S. to assimilate this large mass of humanity; now, therefore, be it	
13	RESOLVED,	that the UIL Congress here assembled make the following	
14		recommendation for solution, enact legislation to regain control of this	
15		situation for the good of our citizenry and the immigrants; and, be it	
16	FURTHER RESOLVED, that it be considered a most urgent need on the legislative		
17		calendar.

A Bill to provide Funding for every High School Graduate to attend two years of Post-high School Education

BE IT ENACTED BY THIS UIL CONGRESS HERE ASSEMBLED THAT: Individuals recognized as a graduate of an American high school will be SECTION 1. 2 provided two years of funding for post-high school graduate education. 3 SECTION 2. Funding will be equal to the cost of two years of in-state university tuition or less, depending on the program. It can be used for private, state, 5 community or technical colleges. 6 SECTION 3. The Department of Education will oversee the enforcement of the bill, 7 with the following three provisions: 8 A. Students eligible for scholarships will have that money subtracted 9 from their funding amount. 10 B. The current Grant program will be used to fund the program, along 11 with additional funding from the private university. 12 C. Colleges and universities will be mandated to lower the cost of the 13 first two years' tuition in the name of garnering interest in their 14 university, so that students will complete their final two years at their 15 place of higher learning. 16 SECTION 4. This program will be in place for the Fall Semester 2015. 17 SECTION 5.
