

A Bill Regarding Landfills

- 1 BE IT ENACTED BY THIS UIL CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1**. Communities shall enforce stricter standards for rubbish, garbage, and
- 3 trash disposal.
- 4 **SECTION 2**. Exceptions shall include rebates for appropriate participation in recycling
- 5 programs.
- 6 **SECTION 3.** Higher fees for trash removal/disposal shall be charged to customers.
- 7 The customer shall be charged based on the amount of rubbish, trash, or
- garbage that would be put into landfills. Enforcement shall be through
- local sanitation/waste removal departments. Fines shall be charged to
- persons attempting to circumvent via illegal dumping or burning of trash.
- Fines shall be established for inappropriate disposal of dangerous
- substances, chemicals, batteries, and e-waste.
- 13 **SECTION 4.** This law shall become effective January 1, 2016.
- **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A Bill to Increase Economic Investment in India

- 6 **SECTION 3.** The Department of Commerce will oversee the implementation of the bill.
- A. In order to ensure the effective implementation of this bill the

 Department of Commerce will initially invest 35 billion dollars in

 India's Department of Infrastructure for a 2 year time period.
 - B. If the investment is properly implemented the Department of Commerce will continue to invest, by an annual rate of 12 billion dollars.
- **SECTION 4.** The bill will be implemented within 6 months of passage.
- SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A Resolution Regarding Antibiotics

1	WHEREAS,	Microbes that cause pneumonia and blood infections in the wounds of
2		military service members are becoming increasingly resistant; and
3	WHEREAS,	Many illnesses no longer respond well to antibiotics being used to treat
4		them; and
5	WHEREAS,	Resistant strains of bacteria usually found only in hospitals are now being
6		found in more common locations in communities; and
7	WHEREAS,	Americans take antibiotics as a reaction to colds, sore throats, and
8		earaches when they are not necessary and doctors overprescribe them to
9		satisfy their patients; and
10	WHEREAS,	More potent antibiotics are not developed because drug manufacturers
11		are placing emphasis on drugs for heart disease, Alzheimer's disease, and
12		depression; now, therefore, be it
13	RESOLVED,	That the UIL Congress here assembled make the following
14		recommendation that tax breaks be offered to drug companies for the
15		development of new antibiotics and that doctors be discouraged from
16		frivolous prescriptions of antibiotics.

A Resolution Regarding Invasive Plants

1	WHEREAS,	Invasive plants are nonnative species that are capable of moving
2		aggressively into a habitat and monopolizing resources such as light,
3		water, and space to the detriment of other species; and
4	WHEREAS,	Estimates indicate that invasive plants are spreading at the rate of about
5		4,600 acres per day; and
6	WHEREAS,	Land values may drop to as low as 10% of their original values when
7		infested with invasive plants; and
8	WHEREAS,	When new plant species are introduced, they come without natural
9		predators; and
10	WHEREAS,	Many invasive plants have aggressive root systems, produce large
11		numbers of seeds, and cast extremely dense shade beneath which
12		natural vegetation cannot survive; and
13	WHEREAS,	The fruits and seeds of many invasive plants are considered "junk food"
14		for the animals that eat them, requiring them to eat more frequently;
15		now, therefore, be it
16	RESOLVED,	That the UIL Congress here assembled make the following
17		recommendation that the intentional planting of invasive plant species
18		be restricted.

1	WHEREAS,	First past the post or also known as winner take all has been in place in
2		the United States and has caused the creation of two party systems; and

5		the Spoiler Effect.; and
6	WHEREAS,	Many individuals are elected without having near the majority of the
7		votes of Americans. First past the post creates a minority rule; and
8	WHEREAS,	The alternative vote works more effectively and allows for small parties a
9		better chance of being elected. The alternative vote eliminates the
10		Spoiler Effect; now, therefore, be it
11	RESOLVED,	That the UIL Congress here assembled make the following
12		recommendation that we eliminate first past the post voting and replace
13		it with alternative vote.

10		become major world powers, such as Brazil; now, therefore, be it
11	RESOLVED,	That the UIL Congress here assembled make the following
12		recommendation that the United States encourage the United Nations to
13		include South American nations such as Brazil to its permanent Security
14		Council, because it is a world organization .

A Resolution to Increase the Amount of Financial Aid Loan Limit

1	WHEREAS,	the cost of college tuition is increasing each year; and
2	WHEREAS,	71.4% of full time college students rely on federal aid each year to pay for
3		tuition and books; and
4	WHEREAS,	each full time undergraduate dependent student has a subsidized and
5		unsubsidized aggregate loan limit of \$31,000; and
6	WHEREAS,	each full time undergraduate independent student has a limit of \$57,500
7		aggregate loan limit; and
8	WHEREAS,	due to a lack of money for tuition most students do not finish school or
9		take longer to obtain their degree; now, therefore, be it
10	RESOLVED,	That the UIL Congress here assembled make the following
11		recommendation that the aggregate loan limit should be increased to
12		\$36,000 for undergraduate dependent students and \$62,000 for
13		undergraduate independent students.

9		FISA court rulings.

5		years due to the increase of unemployment; and
6	WHEREAS,	The American Heart Association has stated that 1 in 3 children ages 2-19
7		are overweight and 1 in 6 children ages 2-19 are obese; and
8	WHEREAS,	It is important to regulate the type of food children eat at a young age to
9		ensure a healthy lifestyle; now, therefore, be it
10	RESOLVED,	That the UIL Congress here assembled make the following
11		recommendation that the United States Department of Agriculture Food
12		and Nutrition Service provide a detailed list with only healthy foods that
13		families will be allowed to buy through SNAP.

A Resolution to Amend the Constitution to Limit the Terms of Supreme Court Justices

2 BE IT ENACTED BY THIS UIL CONGRESS HERE ASSEMBLED THAT:

RESOLVED, By two-thirds of the UIL Congress here assembled, that the following article is proposed as an amendment to the Constitution of the United States, which shall be valid to all intents and purposes as part of the Constitution when ratified by the legislatures of three-fourths of the several states within seven years from the date of its submission by the Congress:

9 ARTICLE --

The justices of the Supreme Court of the United States shall be limited to no more than 16 years of service to the Court, excepting that a justice is appointed upon the death or resignation of another by the President of the United States. In the event that a justice is appointed in this manner, he shall be allowed 16 years of service in addition to the remainder of the term to which he is appointed. Upon passage of this legislation, all sitting members of the court are exempt from its effects.

The UIL Congress shall have power to enforce this article by appropriate legislation.

A Resolution to Require On-Duty Police Officers to Wear Body Cameras

1	WHEREAS,	There is a lack of trust between law enforcement and citizens; and
2	WHEREAS,	The use of video recording technology would allow for an unbiased
3		documentation of interactions between police and citizens; and
4	WHEREAS,	Citizens frequently question the accountability measures taken when
5		police misconduct occurs; and
6	WHEREAS,	Current implementation of police body cameras have seen an overall
7		decrease in use-of-force complaints; and
8	WHEREAS,	Eyewitness testimonies are unreliable and often biased; and
9	WHEREAS,	Video recordings from police body cameras will enhance the
10		department's ability to gather and preserve evidence; now, therefore, be
11		it
12	RESOLVED,	That the UIL Congress here assembled require on-duty police officers to
13		wear body cameras.

A Bill to Cap Campaign Donations

1	BE IT ENACTE	D BY THIS UIL CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1.	All campaign donations in federal elections will be capped at \$250 million
3		per candidate.
4	SECTION 2.	Donations shall include all monies given to a candidate for the purposes
5		of campaigning for a federally elected position. Sources of the donation
6		will not affect the cap. A candidate may not raise more than \$250 million
7		dollars for election campaigning.
8	SECTION 3.	The Internal Revenue Service will keep a tally of each candidate's funds
9		raised for the election period.
10		A. Candidates found in violation of this law will have all campaign
11		donation funds confiscated and donated to their home state's
12		department of education.
13		B. Candidates in compliance with this law will receive public
14		endorsement from the IRS for fair campaign spending practices
15		during the election period.
16	SECTION 4.	This legislation will go into effect beginning with the 2016 elections.
17	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

A Bill to Pass the Academic Partnerships Lead Us to Success Act

1	BE IT ENACTE	D BY THIS UIL CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1.	The Academic Partnerships Lead Us to Success (A-PLUS) Act will be
3		passed.
4	SECTION 2.	The A-PLUS Act would provide states with an opportunity to opt out of
5		the No Child Left Behind (NCLB) law and instead their NCLB funding will
6		be given to the states in the form of block grants.
7	SECTION 3.	The Department of Education will oversee the implementation of this bill
8		on a national level as the bill deals with a federal law.
9		A. Under A-PLUS, if two of three state entities (such as a state's
10		governor, legislature, and state commissioner or superintendent) sign
11		a declaration of intent to opt out of NCLB, then the U.S Department
12		of Energy must grant the state flexibility in how they spend the block
13		grants
14		B. States must still abide by federal civil rights laws and show a
15		narrowing of achievement gaps.
16	SECTION 4.	This bill will go into effect at the beginning of 2015.
17	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

A Bill to Preserve Net Neutrality

- 1 BE IT ENACTED BY THIS UIL CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1.** Internet Service Providers (ISPs) will be required to freely and publicly
- disclose the prices, download speeds, and upload speeds of the services
- 4 they provide to their customers.
- 5 **SECTION 2.** ISPs shall not block or inhibit access to lawful Internet content.
- 6 **SECTION 3.** ISPs shall not unreasonably discriminate against consumers when
- 7 transmitting lawful internet content.
- 8 **SECTION 4.** ISPs shall not prioritize the traffic of certain Internet content providers
- 9 over others.
- SECTION 5. The Federal Communications Commission will oversee the
- implementation of this Bill.
- **SECTION 6.** All laws in conflict with this legislation are hereby declared null and void.

A Bill to Sanction Oil Imports from Venezuela

- 2 **SECTION 1**. The United States will sanction oil imports from Venezuela.
- 3 **SECTION 2**. Oil import sanctions can be reduced to current levels if the Venezuelan
- 4 government agrees to release key political prisoners and implement
- reforms outlined by the opposition party.
- 6 **SECTION 3.** Enforcement of this bill will be carried out by the United States State
- 7 Department.
- 8 **SECTION 4.** This bill will be enacted by January 1, 2016.
- 9 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A Resolution to Strengthen Financial Oversight to Prevent Money Laundering

1	WHEREAS,	\$3 trillion is laundered every year by criminal and terrorist organizations
2		worldwide, often through large, trans-national banking corporations; and
3	WHEREAS,	Such funds received through illicit activities are disguised as legal funds
4		and introduced into streams of legitimate commerce and finance; and
5	WHEREAS,	Such funds often go towards terrorist organizations, drug cartels,
6		organized criminals and kleptocratic regimes; and
7	WHEREAS,	Recipients of laundered money often use their finances to do harm to
8		U.S. interests through terrorist activities and criminal enterprises; now,
9		therefore, be it
10	RESOLVED,	That the UIL Congress here assembled make the following
11		recommendation for the enactment of harsher punishments on
12		individuals and organizations found to be complicit in money laundering;
13		and, be it
14	FURTHER RES	OLVED, That "whistle-blowers" and individuals who reveal instances of
15		banking fraud, laundering, and other misconduct are to be afforded full
16		protection under the Sarbanes-Oxley Act of 2002.

A Bill to Protect Unaccompanied Child Immigrants

1	BE IT ENACTE	ED BY THIS UIL CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1.	The US federal government will establish a procedure for processing
3		unaccompanied child immigrants including providing temporary secure
4		shelters.
5	SECTION 2.	UAC is an undocumented person under the age of 16 crossing the border
6		with no parental or other family supervision.
7	SECTION 3.	Deferred Action for Childhood Arrivals (DACA) will collaborate with Child
8		Welfare to determine a child's placement.
9		A. Anyone 16 years of age or older will be treated as an adult for
10		immigration purposes.
11		B. Child Welfare will attempt to identify the child's parents through
12		cooperation with the government of the child's country of origin and
13		make the necessary arrangements to return the child to his or her home
14		country.
15		C. If the parents cannot be identified, the child's records will indicate that
16		he or she is officially permanently without parents for purposes of
17		immigration.
18	SECTION 4.	This law shall take effect immediately on passage. Any child currently in
19		custody will be processed under this legislation.
20	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

A Bill to establish entrance points to combat the recent Ebola outbreak

- 1 BE IT ENACTED BY THIS UIL CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1**. All US ports of entry will be equipped with the medical technology to test
- persons coming into the US for the Ebola Virus.
- 4 **SECTION 2**. Ports of entry: The access point for all citizens, immigrants, and tourists in
- 5 the US.
- 6 **SECTION 3.** A. The US department of health will provide the ports of entry with the
- medical equipment to test for the Ebola virus, and provide individuals
- 8 responsible for testing for the virus.
- B. The US border patrol will be responsible for securing individuals found
- positive of the Ebola virus, and sending them to proper medical facility.
- 11 **SECTION 4.** This bill will go into effect on Dec. 1, 2015.
- SECTION 5. All laws in conflict with this legislation are hereby declared null and void.
