

A Bill to make military service mandatory to increase America's military power, health, and intelligence.

- 1 BE IT ENACTED BY THIS UIL CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1**. We should make military service at the age of 18 mandatory in the U.S.
- 3 **SECTION 2**. Mandatory-A responsibility or duty of a person.
- 4 **SECTION 3.** The United States Military will enforce it.
- 5 **SECTION 4.** To be implemented immediately, as Congress has approved.
- 6 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

A Bill to Ensure that People are Not Misusing Child Support.

1	BE IT ENACTE	D BY THIS UIL CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1.	In order to ensure that court ordered Child Support isn't misused by the
3		recipient, proof of mandatory employment will be required before the
4		court order takes effect.
5	SECTION 2.	Child Support is defined as court-ordered payments, typically made by a
6		noncustodial divorced parent, to support one's minor child or children. In
7		this case misusage means that one is dependent on Child Support checks
8		and does not have a current job that provides a money source other than
9		the checks.
10	SECTION 3.	The Child Support Agency (CSA) shall be in charge of enforcing this bill.
11		A. The Child Support Agency will make sure that every individual in the
12		United States of America that receives Child Support checks hold
13		employment other than said Child Support.
14		B. If after two months an individual does not have employment other
15		than the Child Support, the Child Support will be revoked until they
16		are employed.
17	SECTION 4.	This bill will be implemented 6 months after passage.
18	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

A Bill to Require all Eligible Voters to pass a Citizenship Test before becoming a Registered Voter.

- 1 BE IT ENACTED BY THE UIL CONGRESS HERE ASSEMBLED THAT:
- 2 **SECTION 1**. Before becoming a registered voter, one must pass a citizenship test.
- 3 **SECTION 2**. Citizenship test refers to the naturalization test immigrants to the United
- 4 States currently take.
- 5 **SECTION 3.** The Department of Immigration and Naturalization will oversee the
- testing and Enforcement of passing a citizenship test before becoming a
- 7 registered voter.
- 8 **SECTION 4.** This law will take effect within six months of passage
- 9 **SECTION 5.** States who refuse to comply with this law will lose 2% of their Education
- 10 Funding.
- SECTION 6. All laws in conflict with this legislation are hereby declared null and void.

4		28.8 micrograms of cocaine depending on the year and city; and
5	WHEREAS,	If an individual has a large amount of legal money Police Officers have the
6		right to seize it if a K-9 smells cocaine on it; and
7	WHEREAS,	one cannot reclaim money after it is seized by the police; now, therefore,
8		be it
9	RESOLVED,	That the UIL Congress here assembled force the Texas Law Enforcement
10		Agency to implement a way to differ contraband money from legal
11		money before confiscating it.

9		aid are being rejected for Welfare every day; now, therefore, be it
10	RESOLVED,	That the UIL Congress here assembled shall disallow all current and
11		future lottery winners from applying for government aid; and, be it
12	FURTHER RES	SOLVED, That the Lottery Commission shall be required to report all Lottery
13		winners to the Department of Health and Human Services.

A Resolution to Create Jenise's Law

WHEREAS, The FBI counts 2,100 missing-children reports every day some of which are not reported within 12 hours of the disappearance; and

WHEREAS, The United States of America has a duty to keep its citizens safe as best as possible likewise parents have the same obligation; and

WHEREAS, Parents have an obligation to their child to provide a safe environment and to always make choices to the best interest of the child; now, therefore, be it

RESOLVED, That the UIL Congress here assembled creates Jenise's Law to make the failure of reporting a missing child after 12 hours of the child being missing a felony.

A Resolution to Ban Cosmetic Testing on Animals

1	WHEREAS,	Cosmetic testing on animals is extremely cruel; and
2	WHEREAS,	17-22 million animals per year are subjected to tests that include skin and
3		eye irritation tests where chemicals are rubbed on shaved skin or
4		dropped into eyes without pain relief; and
5	WHEREAS,	31% of animals used in testing are euthanized afterwards; and
6	WHEREAS,	testing be done on reconstituted human skin instead of animals;
7		Now therefore be it
8	RESOLVED,	That the UIL Congress here assembled ban cosmetic testing on animals.
9	FURTHER RES	OLVED, that cosmetic testing on animals be considered animal cruelty.

A Resolution to Ban Native American Mascots and Logos

1	WHEREAS,	The use of Native American mascots and logos present a negative and
2		misleading image of the Indian people; and
3	WHEREAS,	Widely viewed images of Native American stereotypes in commercial and
4		educational environments slander, defame, and vilify Native peoples,
5		Native cultures, and tribal nations, and continue a legacy of racist and
6		prejudiced attitudes. In particular, the 'savage' and 'clownish' caricatures
7		used by sports teams with "Indian" mascots contribute to the "savage"
8		image of Native peoples, and the myth that Native peoples are an ethnic
9		group "frozen in history." All of which continue to plague this country's
10		relationship with Native peoples and perpetuate racial and political
11		inequity; and
12	WHEREAS,	A 2004 study conducted by Stephanie Fryberg, a preeminent cultural and
13		social psychology scholar and an enrolled member of the Tulalip Tribes in
14		Washington state, showed that "the use of American Indian-based
15		names, mascots, and logos in sports have a negative psychological effect
16		on Native peoples and positive psychological consequences for European
17		Americans. Additionally, Fryberg has concluded that these mascots have
18		negative effects on race relations in the United States; and
19	WHEREAS,	the trend to use Native American mascots and logos is disrespectful and
20		harmful to Native Americans; and
21	WHEREAS,	it has negative effects on race relations in the U.S.; now, therefore, be it
22	RESOLVED,	that the UIL Congress here assembled make the following
23		recommendation: that the United States ban all Native American mascots
24		and logos.

A Bill to Declare Illegal Synthetic Cannabinoids and Compound Drugs

1	BE IT ENACTE	D BY THIS UIL CONGRESS HERE ASSEMBLED THAT:
2	SECTION 1.	It is unlawful for any person to knowingly manufacture, distribute, sell, or
3		cultivate any form of synthetic cannabinoid, compound drug, or sister
4		compound.
5	SECTION 2.	A synthetic cannabinoid shall be defined as any chemical compound that
6		is chemically synthesized and has been demonstrated to have binding
7		activity on one or more cannabinoid receptors. A compound shall be
8		defined as anything that is composed of two or more separate elements;
9		a sister compound shall be defined as any compound derivative of or
0		similar in composition to known any psychoactive drug.
1	SECTION 3.	The government agency overseeing the enforcement of this bill will be
2		the DEA.
3		A. Any violation of an ordinance declared by the DEA on this matter shall
4		be punishable by a fine of between \$500 and \$5,000.
5		B. A second offense will be punishable by a fine between of up to
6		\$100,000 and three years imprisonment.
7	SECTION 4.	This bill will take effect immediately upon passage.
8	SECTION 5.	All laws in conflict with this legislation are hereby declared null and void.

6	WHEREAS,	Space is becoming an increasingly pivotal tool of foreign policy in which
7		the United States is falling behind and is surpassed in by many other
8		nations; and
9	WHEREAS,	It is potentially devastating and harmful for the United States to lose this
10		position as it is through this that we maintain hegemony and global
11		influence; now, therefore, be it
12	RESOLVED,	That the Congress here assembled make the following recommendation
13		to encourage spending and research by NASA and to approve funding
14		requests from NASA; and, be it
15	FURTHER RES	SOLVED, That no grant shall exceed the estimated cost of \$30 billion.

10		much as 15 years later; now, therefore, be it resolved
11	RESOLVED,	that the UIL Congress here assembled recommends that public places
12		limit adult programming to hours after 10:00 PM.

- **SECTION 6.** All laws in conflict with this law or legislation will not be considered in
- relationship to the bill itself.
