1. There shall be no political announcements or advertising of liquor, alcohol, tobacco or gambling during the telecast.
2. The Station is to be responsible for any expense incidental to setting up the broadcasting arrangements.
3. This Station shall not feed this broadcast of the game to any other Radio Station without the signed approval of the two schools playing the game.
4. The Station shall make arrangements with IMG to broadcast 3A, 4A and 5A football quarterfinals, semi-finals and finals. See UIL website for more information.
5. The \_\_\_\_\_ High School shall not be liable for any expenses incurred by the station stated above in putting on the broadcast.
6. If the carrier is also doing an over-the-air broadcast, Internet Audio Simulcasts may carry a rights fee. \_\_\_\_\_ (Station name/website) will carry a simulcast of above game.
7. That the company provide competent and professional-like announcers and broadcasting; and that no dramatization shall be made of any unsportsmanlike conduct, incidents or displays on the part of the participants or fans.
8. There shall be no negative criticisms of officials' decisions.
9. No mention shall be made of injuries, unpreventable accidents, or other incidents which may cause any anxiety on the part of the listeners.
10. There shall be no discussion of University Interscholastic League policies which are of a controversial nature.
11. That this agreement is for on-the-air broadcast rights only. Any reproduction or copy of this broadcast shall not be sold or distributed without prior written consent of both high schools stated above.
