| 3 | | automatically registered as an organ donor to increase the number of |

| 6 | | Organ Donor: An individual whose body or part is the subject of an |
| 7 | | anatomical gift. |

| 7 | SECTION 3. | The House Committee of Oversight and Government Reform shall |

8 A. Individuals may choose to opt out of voter registration by mail or

9 through the newly created government website.

A Bill to End Book Bans in Public Schools

 access while at school.
- 5 **SECTION 2**. A public school district is a geographical unit for the local administration
- 6 of elementary or secondary schools. It is a special-purpose government
- 7 entity that can be administered independently or be dependent on the

8 local government, such as a city or county.

- 9 **SECTION 3.** The Department of Education (DOE) shall ensure enforcement of this law.
- 10 A. Public school districts shall have 40 days to repeal any book
- 11 restrictions put into place before the passage of this law.
- 12 B. Families who reside in districts who lose federal funding shall be given
- 13 the option to attend a neighboring district, which will receive funding
- 14 for adding new students.
- 15 **SECTION 4.** This legislation will go into effect January 4, 2025.

A Bill to Increase Infrastructure Funding for Federal Reservations

 Interior and the Bureau of Indian Affairs, will obtain increased funding in
- 4 instances of inadequate conditions.
- 5 **SECTION 2**. Infrastructure is defined as surface transportation, broadband internet,
- 6 renewable energy generation, electricity transmission, airport capital
- 7 improvement, ports and waterways, and oil or gas pipelines.
- 8 Federal Reservations is defined as an area of land reserved for a tribe or tribes
 9 under treaty or other agreement with the United States.
- 10 SECTION 3. The Department of Interior (DOI) and the Bureau of Indian Affairs (BIA) will
- 11 oversee the enforcement and implementation of this bill. The Department of
- 12 Interior (DOI) will oversee the reservations' public lands and minerals, national
- 13 parks, national wildlife refuges, and western water resources and uphold
- 14 Federal trust responsibilities to Native American tribes. The Bureau of Indian
- 15 Affairs (BIA) will oversee and expedite all infrastructure building projects and
- 16 preparations. Funds will be distributed upon square mileage of reservation,
- 17 available funding toward infrastructure projects, and overall necessity as
- 18 negotiated by the Bureau of Indian Affairs.
- 19 **SECTION 4.** This bill will go into effect Jan 31, 2024.
- 20 **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void. Introduced for UIL Congressional Debate by Mount Pleasant High School.



A Bill to Guarantee Federal Jobs to Help Combat Inequality
