

# UIL Speech State Meet Procedures Qualifying Schools

## Registration and Entry Fees:

Speech State Meet 2024 is an in-person meet and will be run using our tournament management system **SpeechWire**. All ballots, pairings, schematics/sectioning, announcements, and results will be electronic. You will need to create accounts for your students in Extemp and link your judges if you qualified in LD.

There are no entry fees to the UIL Speech State Meet, but there are judge requirements and deadlines for submitting judge forms for schools qualifying in Lincoln Douglas Debate. There are Documentation online submissions for Prose/Poetry.

**DO NOT SEND STUDENT FORM TO THE STATE OFFICE.**

⇒ If you have a student qualified in INFORMATIVE or PERSUASIVE SPEAKING you are required to create student accounts for them in **SpeechWire**.

⇒ Schools who qualified students in LD Debate are required to provide judges. First off, you do **NOT** need to ask your judges to create their own SpeechWire judge accounts. **Judges should NOT create their own accounts on SpeechWire!** As you register them, if they don't already have an account, one will automatically be created for them and they will be emailed login details to use to judge the tournament.
