Registration and Entry Fees:

This is a virtual meet so coaches must register in SpeechWire in order for your qualifier(s) to compete. Registration instructions are posted separately on this information webpage. Ballots will be electronic so you must be registered. There are no entry fees to the UIL Speech State Meet, but there are judging requirements for those qualifying in Lincoln Douglas Debate. Ballots will be electronic.
