<u>Hospitality Room</u>

A hospitality room will be available on Friday for directors, administrators, bus drivers, adjudicators and contest staff. This will be located in theatre department office located just across the hall from the stage inside Door 12 of the HS. Snacks and drinks will be provided throughout the day.

Dressing Rooms

Dressing rooms will be provided for each company. This will be your home for the day. Make absolutely sure that <u>NO ONE</u> except those listed on the eligibility MACH form is allowed in your dressing room. Friends, family, bus drivers and administrators are NOT allowed in the dressing rooms ...only cast, crew, alternates and directors. Please make everyone aware of this UIL rule. Make sure that your dressing rooms is clean when you leave. Tables should be free of make-up residuals and all trash should be removed from the area.

Performances

The performances will run back-to-back so please let parents know so they can arrive in time for the performance. Casts are reminded not to re-enter the auditorium in make-up or costume after the performance. Remind your students and parents that if they enter the theatre during a performance, they are required to sit in the upper section seats.

Time warning procedures

The stage manager will be giving audible calls from the edge of the SL wings for set and strike. The stage manager will give a time warning when 15 minutes have elapsed during the play. He will also give a 35-minute warning to each school's designated stage manager. Your designated crew member should respond with "35-minute warning received." Additional warnings will be given at 5 minutes, 3 minutes, 2 minutes, 1 minute, 30 seconds and 15 seconds remaining. You will be asked to confirm. No other warnings are given.

Admission to the contest

Tickets will be available at the door. The cost is \$10 per person. One ticket will be good for all six shows. Each school will be allowed 5 free passes to the contest. Directors will need to email the names of those individuals to <u>gary.davis@dcisd.org</u> to be included on the pass list.

<u>Load-out</u>

Following the performance, companies will strike out of the stage right door and down the hallway. Buses should meet the companies at Door #12.

<u>Latecomers</u>

Please let families and friends know that if they arrive late, they may enter, but should sit in the upper-level seating. Also, in order to maintain the proper atmosphere for enjoying a live performance, we ask you to <u>let your families and friends know that no photographs (flash or otherwise) nor video-recording may be taken during the performances</u>. This has been an issue in the past and we need everyone to be aware that this is a violation of international copyright law.

Critiques and awards

Critiques will be held after all performances have been completed but before the announcement of results. Critiques will occur simultaneously in three separate areas. After all critiques are completed, the awards will be presented.

<u>Technical preview</u>

If you would like to schedule a 60-minute preview of the facilities... including the sound and light boards...please contact Gary Davis at 806-592-1130 so that he can make arrangements for you. The light board is an MA dot2 and the sound system has a plug in for tablets, computers, and phones. **It does not have capability for the use of a CD player**. You are welcome to run your sound through the house system or you may bring your own sound systems and speakers.

Adjudicator Script

Immediately following your district contest, please mail a copy of your approved script to each of our adjudicators so they may receive them by Tuesday, April 2, 2024 if possible. Make sure that your scripts are clearly marked to reflect your performance (highlight the lines that you are using and strike-through the lines that you are omitting).

<u>Eligibility</u>

These forms are due to the contest manager, Cindy Couch before you will be allowed to begin your official contest rehearsal.

- 1. Any correspondence, if any, from UIL approving scenic items, special properties.
- 2. Written evidence of royalty payment.
- 3. Publisher's approval to produce a one-act or scenes from a long play for contest.
- 4. If the play is not on one of the approved lists, written evidence of League permission.
- 5. A signed "Community Standards and Copyright Compliance Form."
- 6. A clearly marked integrity script with live music cues included.

The integrity script is in addition to the script provided to adjudicator.
