ADJUDICATORS

Larry Balfe – "One-Act Play changes lives. I have the opportunity to learn something new every time the house lights go down and the stage lights illuminate the work of the directors, actors and technicians. I appreciate productions where the company commits to the director(s)'s choices in interpreting the world the author created." Mr. Balfe directed four different schools to the State Meet finals, winning twice and advancing 19 productions to the Regional Meets. He has been judging since 2011, four times at the State Meet, 15 Regionals and over 100 contests and clinics around Texas.

Connie Gilseth – Retired from teaching after 26 years at the high school and middle school levels. She is now a free-lance actor, choreographer and costume designer. She had six shows advance to the State Meet, winning first with *Look Homeward*, *Angel*. "I look for a good story, well-told. The genre of the play does not matter. I want to see actors living their characters honestly while creating relationships with all actors on stage."

Kelly Parker – For the past 17 years, Mr. Parker has worked at McLennan Community College as Professor of Theatre and Coordinator for the Department of Theatre, while teaching acting and directing productions. Prior to embarking on a career in education, Mr. Parker performed in and directed professionally throughout the United States. He is a registered Advanced Actor Combatant with the Society of American Fight Directors, a certified intimacy choreographer, yoga teacher and member of the Texas Educational Theatre Association, from whom he received the Higher Education Teacher of the Year award in 2018.

SPIKE TAPE WILL BE PROVIDED.

In your one-hour of rehearsal, your company will set, determine light cues, spike, set sound levels/strike. Please plan accordingly. It is strongly recommended that you practice your official rehearsal prior to the day of the contest site rehearsal.

Full disclosure of your set and all props will take place during your rehearsal, including stage business that poses potential safety issues.

MARCH 27

ORDER OF PERFORMANCE: The Order of Performance was determined by a blind draw with the letter "A" representing the title of play that comes first alphabetically from each district and the letter "B", the title that comes second and the letter "C" the title that comes last, excluding articles.

The plays will run back-to-back.

- In accordance with UIL rules, only directors, cast, crew and alternates that are listed on the District Entry Form are
 permitted in your respective dressing room, Alternates are not permitted backstage during the set, performance and
 strike
- Schools are responsible for feeding their respective companies. A Hospitality Room will not be provided for directors, bus
 drivers, administrators, etc.

There will be a \$5.00 admission charged to the public audience.

STAGE/FACILITY The use of particulates such as powder, flour, glitter, small confetti, etc. shall be approved by the CM and Host Site PRIOR to the scheduled rehearsal. This includes their use as effects, on costumes, props and/or set pieces. The use of haze and fog is permissible. Wireless intercommunication is provided. In this packet is a diagram showing all drapery locations, stage dimensions and the light plot.

UNIT SET The complete unit set will be available for use, including one door, one window and a set of French doors. Contact the contest manager should you need additional doors or windows. Everyone must use the basic set that is provided, including the in-house, intercommunications system. An 8' step ladder is provided along with stage weights, as needed. If you need additional doors, bring those with you.

SOUND Each company is welcome to use the house sound system, but may bring their own to operate from backstage, if so desired. Hamilton will provide the needed AUX cable to run sound from your computer/load to the board. The use of CDs is highly discouraged.

LIGHTS Please email or call Melissa Craiq with any questions in regards to the lighting system. Light plot found in this packet.

All cues will be run live.


