# Important Information

## 1. Eligibility Notice

Please complete all required documents for UIL (Contestant Entry) Program copy will be sent to you prior to competition. Proofread carefully. Corrections will be made and a final program copy will be sent to you. Please print as you will. No programs will be available at the contest site. A QR CODE will be posted in the lobby for patron access to the program.

## 2. Rehearsals

Please ARRIVE 30 minutes prior to your assigned REHEARSAL TIME.

The Contest Manager and/or Stage Manager will meet you and your company at the loading dock door on the back side of the theatre building (a map will be sent in a separate email) , **at least 30 minutes before** your scheduled rehearsal time. Please be on time. You will be directed as to where you may park your vehicles after unloading. Your contest manager and stage manager will give you instructions, answer questions, and assist you in the unloading and setting up for your rehearsal.

To ensure compliance with UIL rules, remember that all uses of the basic set must be fully disclosed to the contest manager at the official rehearsal. Unauthorized or undisclosed use of the basic set will be addressed. The contest manager shall make any decision concerning the use of the basic set and that decision shall be final.

You will have **a minimum of 1 hour 0 minutes** to rehearse on stage. Be sure that you set and rehearse your technical cues first. Most importantly, establish your light cues - this will be your only time to record them. **There is a strong probability that you will not be able to run your full show in rehearsal.** If your show has simple light cues, this will only take a few moments. If your show has many complicated cues, you should allow a large portion of your rehearsal time to establish these cues. **You will need to spike your set within your one hour rehearsal. You should be completely struck by the end of the hour.**

You may use your rehearsal time any legal way you wish. Please remember that whatever you don't get accomplished at your rehearsal cannot be adjusted later (including lights). Each school must get exactly the same minimum amount of time on stage in rehearsal.

## 3. Notes

Food and drink of any kind will not be permitted in the theatre.. Also, in order to maintain the proper atmosphere for enjoying a live theatre performance, we ask you to let your family and friends know that no videos, flash photography or otherwise, may be taken during the performances. Audience members with young children that might become unattentive/disruptive will be asked to retire to the lobby and may not be allowed back in during the performance. Some plays may contain mature subjects. Each play performed today has their school's documented approval for the play that is being performed by their school.

### **Regarding Performance Critiques/Awards.**

Critiques will occur in the auditorium simultaneously as soon as possible after the last performance. Awards will occur as soon as possible after critiques are completed.

## **5. Awards**

Region contest will award the following bill:

- Two (2) Advancing Plays (To UIL State Meet)
- One (1) Alternate Play;
- 2 Outstanding Performers, 8 All-Star Cast, 8 Honorable-Mention, All-Star Cast (Individual Awards);

From the UIL Leaguer: “The Decision: Accepting the judge’s decision requires graciousness on the part of those who advance as well as those who don’t. Receiving an award in the One-Act Play Contest is no reason for a riotous demonstration. Applause is the ONLY acceptable method to pay tribute in the theatre. Your task as director is to instruct your students on acceptable theatre etiquette.”

## **6. Integrity Script/Required documents**

These forms are due on entering your official rehearsal. If you are producing scenes from a long play, you must submit show approval from the publisher and/or playwright to cut the script for OAP purposes. Please see the Director’s checklist for due dates and necessary paperwork required. Entry fee due at rehearsal.

## **8. The following rules are designed to allow the contest to run effectively:**

- During rehearsal, the theatre and stage must be entirely clear of all persons except the rehearsing company and the host crew.
- Casts and crews should remain professionally quiet both in approaching and leaving the stage area during rehearsal and contest.
- Please have one crew member assigned to be in charge of all wallets, purses, watches, cell phones and jewelry during rehearsals and contest. CMISD will not be responsible for lost or stolen valuables.

**9. Dressing Rooms.** Each school will be provided a preparation area in the gym with dressing rooms in close proximity to the area for the day’s event. Please take every measure to leave it clean and as it was upon entering.
