JUDGE INFORMATION:

I am very pleased to announce that we have an OUTSTANDING panel of adjudicators to work with your students.

Larry Balfe (acting judge) believes that UIL One Act Play changes lives. From the very first time he attended the state contest, he found a path to a career which he still loves. All these years later, as a veteran of the One Act Play process, he realizes most of his life has been dedicated to this activity as an actor, technician, director, contest manager, and an audience member. VENUE SPECIFICS:

The stage measures 87' x 54' at its deepest point, with the apron measuring 14'. The host site strongly encourages pulling your entire show downstage onto the apron. The legs and travelers can be pulled in as needed in order to make the stage seem smaller. A mid-stage traveler and back stage traveler are available and are controlled by pulleys on stage left. There are also various legs that can be pulled in or flown out by the site crew.

A complete unit set is available for all participating schools (including door and window units). A cyclorama is available for schools that wish to use it. The use of fog IS permissible in this venue.

This venue has an ETC Ion Console with a combination of LED and incandescent fixtures. There are 15 lighting areas, each controlled by subs (1-15). There are additional lighting areas (16-20) available for the deeper parts of the stage. Washes and cyc lights are LED and available in any color.

The house sound system can be controlled from both the booth and the wings. Schools may use CDs or plug in a device via an aux cord.

LOAD IN/LOAD OUT PROCEDURES:

Upon arriving for your official rehearsal, please CALL ME at (254) 640 - 5785. A member of the contest staff will come to greet you and let you into the PAC.

The parking lot leading to loading dock is very long, so schools may wish to use the curb at the front of the building or on the adjacent road (Town North) and carry set pieces in instead of trying to back all the way in.

Buses/trailers will need to be parked in front of the PAC after loading and/or unloading, and may not block any cars that are in the parking lot.

Each school will load out immediately following their performance at the conclusion of their 7minute strike period. Please have your bus/trailer positioned and ready to go as soon as your performance begins. Having a smooth load out process will help us keep the contest moving as quickly as possible.

OFFICIAL REHEARSAL PROTOCOL:

This is a two-day contest. Rehearsals will occur on March 21 and performances will occur on March 22. The rehearsal/performance order was determined through random draw and is determined based on show title:

The first moments of your official rehearsal will be reserved for me to check over your required paperwork/any prop weapons/alcohol, etc. During the rehearsal period, I must see the opening and closing sequence of your show as well as any instances of stage combat. Other than that, you can use the rehearsal period to do whatever you would like, but you must begin clearing the stage in the last 5 minutes of the period.

CONTEST PERFORMANCE ORDER:

The director's meeting will occur at 9:00 AM. The first show will begin at 10:00 AM, and the remaining performances will occur on a rolling schedule.

The performance order is as follows:

 1^{st} – District 14, Title B 2^{nd} – District 13, Title A 3^{rd} – District 13, Title B 4^{th} – District 14, Title C 5^{th} – District 13, Title C 6^{th} – District 14, Title A

Critiques will occur **PRIOR** to the awards ceremony. Please make your way back to the house as quickly as possible to allow for us to start the process as soon as we can.

COMPETITION ENTRY FEES:

There is a \$1000.00 entry fee for each competing school in this contest. Checks should be brought with you to the competition and turned into the contest manager at the start of your official rehearsal.
