## JUDGE'S SCRIPT

Please overnight copies of your script to the critic judges at the addresses above.

- Do not send a Xerox copy. The script will be returned.
- Make sure the scenes you are not using are "x-ed" out and that the remaining dialogue is highlighted in yellow.

## ENTRY FEE AND REQUIRED DOCUMENTATION

Have the following ready to present to the Contest Manager at your rehearsal

- Entry Fee: The fee for each school participating in the area contest is \$450.00 to help cover expenses of the contest. I have included a invoice. Remit this fee by school check made payable to Randall High School. A school will not be allowed to compete until the entry fee is paid. If a school has difficulty getting a check in the short time between the district and area contests, a letter from an authorized school administrator stating that the entry fee is being processed will suffice. In that case, mail the check (made payable to Randall High School)
- Proof of Royalty Payment, Publisher's Permission to Cut, And State UIL Approval Letters: This includes documentation required for your performance such as permission for cutting long plays, play approval if the play is not on the approved list, letters of permission for additional scenery or any written clarifications from the State UIL office.
- Script and Music Cue Log

Present a copy of the approved published original script, in addition to the one you have provided for the judge, marked to reflect the exact performance text being used.

Prepare a music cue log sheet.

## Rehearsal/ Performance Schedule:

Rehearsal schedule will be done by distance. As soon as all the schools contact me I will send out a rehearsal schedule. Please indicate if you would be able to rehearse Friday 3/30/18 in the afternoon/evening. Rehearsal will begin the morning of at 7:00 A.M. Director's meeting will be at 1:00 in the High School Office. The first show will start at 2, and the shows will run back to back.

The drawn performance order is: A is Bi-District A; B is Bi-District B. Numbers determined by Show Title

1. A School 2
2. B School 2
3. A School 1
4. B School 3
5. B School 1
6. A School 3

Unit Set: We have all pieces of the BASIC set. We have one door unit. If you need more than one, a French door, or a Window Unit, you will need to bring that.

## Dressing Rooms:

Each School will have a room to use the entire day. You will need to bring mirrors for make-up application.

Lights and Sound : If you plan to use our CD player it is located in the light booth. Our sound system can play a CD or an Ipod. We will have walkie talkies between backstage and the booth, however you may bring your own.

#### ADMISSION CHARGE

We will charge an admission fee of \$5 for the entire contest. This is to help augment the cost of the contest in an attempt to not charge each school more to compete.

#### AWARDS AND CRITIQUES

Plaques will be presented to the three advancing plays. Individual medals will be given to best actor and actress, all-star cast, honorable mention. We will also have an award for best technical crew. The critique is a very important part of the OAP process. Please be courteous, attentive, and receptive towards the judges and other casts. The critiques will be given according to geography with the farthest school being first. The three advancing shows will be critiqued last.
