**IMPORTANT
SCHEDULES AND PROCEDURES
FOR RELEASE OF THE
RECLASSIFICATION AND REALIGNMENT**

Reclassification and realignment information for 2020-21 and 2021-22 will be released on February 3, 2020, at 9:00 a.m., Central Standard Time (8:00 a.m. MST in El Paso) at respective Regional Education Service Centers.

The information will be distributed through the Regional Education Service Centers or as listed below. Schools may also access reclassification information on the UIL web site (www.uiltexas.org) and print alignments. If there is an error in assignment or a school has been omitted, schools are to notify the League office via phone (512-471-5883) or email (alignments@uiltexas.org).

- February 3-14, 2020 Schools wishing to change districts may do so by getting a majority vote from both the district to which they have been assigned and the district to which they wish to change. If a majority vote is achieved from both districts, both district chairs must notify the UIL office by phone and follow with written notification. The school appealing should fill out the Appeal Form.
- February 14, 2020 Deadline for a participant school to request an appeal of their district assignment to the UIL office. The school must file its request and a supporting statement with the District Assignment Appeals Committee. The school appealing must inform in writing the superintendent and principal of the schools in the conference and district to which it was assigned as well as the superintendent and principal of the schools in the conference and district to which it wishes to be assigned. Notification in writing must go to all schools that could be involved in the change. The District Assignment Appeals Committee will not consider appeals with respect to conference assignment unless there was an error in the enrollment figures submitted.
- February 25, 2020 The UIL District Assignment Appeals Committee hearing will be held February 25, 2020, beginning at 9:00 am at the Courtyard by Marriott Pflugerville, 16100 Impact Way, Pflugerville, TX., 78660. When all appeals are completed, the District Assignment Appeals Committee shall approve the assignments to districts. Until this approval, contracts for contests by participant schools are not effective.
- February 26, 2020 First day for District Executive Committee meetings to set district schedules.
