MEET BEHAVIOR: It is expected that all persons attending this meet will respect the facilities and remember that they represent themselves and their respective schools/teams. It may also result in expulsion from the meet. **Remember it is a UIL violation for swimmers to shave down on site. Swimmers MUST be dry before entering lobby area from pool deck.**

WARM-UP: The warm-up procedures for Friday will be determined by team size and distance from the Natatorium. A separate 6 lane pool (West End) will be available during the meet for continuous cool-down and warm-up. Friday only we will use the 4 lanes in the east pool for warmups, then it will be shut down for the remainder of the meet.

Saturday will be open warmups, with the last 25 minutes allowing for push/pace and one-way dives.

ENTRIES: Swimmers are automatically entered in the Region Meet through the district meet representative, no changes are permitted. If coaches are going to remove a swimmer from an individual event in order to swim three (3) relays, every effort should be taken to do that at your district meet site. If not, any changes must be done prior to the UIL Region Meet Entry

Deadline; **Monday, February 3rd at 4:00 pm.** Every effort will be made to contact the next qualifier in that event. Once entries are received, no changes are permitted, unless swimmers are scratching the entire meet. **Make sure your UIL Team Codes and numeric grade levels are correct prior to emailing your entries.** Once a swimmer swims on a relay it will count as one of their events allowed in the meet. National H.S Federation & UIL rules apply to entry requirements. Relay swimmers must be declared prior to the start of the relay. List up to eight (8) names for all relays entered. Changes to relay personnel must be from those eight (8) swimmers listed.

Entry

Deadline:

The entry deadline is 4:00 PM, Monday, February 3rd. Coaches should email their entries to the Meet Director, Brad Quindt, at brad.quindt@humbleisd.net. In the email, attach the Meet Manager File (Hy-Tek or Team Unify) along with the PDF Entry Report, sorted by "Meet Event Number" and show 8 names for relays, if you wish. The 8 must be declared at the designated time at Prelims. Include your team name in the subject of the email. If you have a swimmer that qualified in the top six (6) at your District Championship Meet, but is not competing in that individual event, make a note in the email body. **Additionally, all divers should be entered with the swimmers. Dive sheets will be entered using clean entries must be submitted by Monday, February 3rd by 11:59p.**

The Meet Director shall, upon receiving each e-mail, notify the appropriate party of the receipt and any problems noted with the files within 24 hours. If no reply within the specified time, please contact the Regional Meet Director immediately.

District meet directors shall **e-mail** the Hy-Tek backup file to the Region Meet Director upon the conclusion of their respective District Championship.

DIVING

ENTRIES:

Divers must be indicated as participating in 1M Diving on the entry file/sheet submitted with the swimmers.

Sheets:

Dive sheet should be submitted electronically by Wednesday, February 5th by 3:00p. Access www.cleanentries.com to register you, your team and the divers. The meet will be available as "2025 UIL Region VI-6A". The rules in the National Federation Swimming and Diving Rules and Records Book shall be followed regarding dive list format for entries. All diving sheets must be signed by the diver and the coach one hour before the start of the meet. Failure to have these signatures will disqualify the diver from the competition. Changes may be made up to one hour before competition begins.

ENTRY FEES: \$20.00 per athlete including relay only and alternate swimmers, \$20.00 per relay entered.

i.e.: 5 athletes (1 relay only, 1 alternate) entered and 2 relays = \$100.00 for athletes + \$40 for relays = \$140.00

Entry fees are based on preliminary psych sheet when published. This includes names of swimmers listed on your relays. So please be mindful random kids on relays, if you know they will not swim, do not list them as you will be charged. If, for any reason, a swimmer/diver should fail to compete there will be no refunds.

Since this is the week of the meet, it is not anticipated that an entry check will be received before the meet. Your team will receive an invoice when reporting for the preliminary session. It is expected that this will be processed immediately.

Substitutes: Individual school coaches should inform their District meet directors of any scratches prior to the entry deadline. The District Meet Director will, in turn, inform the Region Meet Director of the scratch, and the name and qualifying time of the alternate for the event in question.

After the entry deadline, no changes of entries will be allowed unless the contestant is being scratched from the meet. If one of your swimmers qualifies in an event that you know he or she will not swim at the Region Meet, please have the person completing your Region entries make the necessary changes prior to turning in the Region Entry Forms. Indicate in the email body, the changes that were made and write "scratch or SCR" in the event they had qualified in.

Changes/

Adjustments: After the entry deadline has passed (4:00 pm, Monday, February 3rd), the psych sheet will be emailed to the email address you provided.

Adjustments from scratches and alternate entries will be made as long as possible. After the prelims begin, a scratch will result in an open lane.

After the prelims are completed, scratches and alternates will be accepted for one hour.

Once the finals have started, a scratch will be filled with an alternate or the lane left open.

Please review Rule 3, Section 1, Article 1, and Section 2, Articles 1, 2, 3, and 5 of the NFHS Swimming and Diving Rules Book concerning meet entries and meet conduct for championship meets.

No changes will be made after the entry deadline.

EVENTS: The events and their order will follow that found in the NFHS Swimming & Diving 2024-2025 Rules Book, Rule 5, Section 1, and Article 1.

PACE OF

PRELIMS: During Prelims, fly over starts will be utilized and there will only be 3 breaks; 5 minutes after the Medley Relay, 15 minutes after the 50 freestyle and 5 minutes after the 100 breaststroke.

PACE OF FINALS:

We will announce the participants in the Consolation heat as they swim. Championship Finalists will walk in from under the big scoreboard to music to their blocks, and then will be announced before they swim.

Break/Awards:

Swim Events 1-2	10 Minute Break
Swim Events 3-8	30 Minute Break (Present awards for events 1-8*)
Swim Events 11-14	20 Minute Break (Announce 9-10, Present awards for events 11-14*)
Swim Events 15-18	20 Minute Break (Present awards 15-18*)
Swim Events 19-22	20 Minute Break (Present awards 19-22*)
Swim Events 23-24	Award remaining events awards*

***1st Place coach in each event is to present the awards**

AWARDS:

U.I.L. medals will be given to the top three competitors in each event. In addition, a plaque will be presented to the winning relay in each of those events. TISCA will be providing ribbons for places 4-8. There will be a team award for the winning teams (male and female). Individual and Team Awards will be awarded after the last event award. Diving awards will be presented at the diving event and recognized at the swimming meet. The presentation of awards is included in the timeline of the breaks.

SCORING:

The top 16 shall advance from preliminaries: the fastest (8) to the finals and the next (8) to the Consolation finals in each event, scoring will be to sixteen places. The highest place a Consolation finalist may earn is 9th – even if they have a faster time than a top-8 finalist. The point values will be as follows:

Tie breakers:

If two or more divers have the same score at the end of the competition, the points will be split and a coin flip will determine the medal award. If there are ties in swim events, the points will be divided and the preliminary time will determine the place for advancing. If a tie still exists, a coin flip will decide the place. No additional medals will be provided for divers or swimmers.

Qualifiers: (h) CHAMPIONSHIP STRUCTURE. (From the UIL Swimming and Diving Manual)

(2) Qualifiers to Regional. Top six (6) individuals and relays shall qualify from district to regional.

(3) Qualifiers to State. The first place and second place in each of eight regional swimming meets and the next eight swimmers with the best regional final times overall will advance to the state meet.

(4) Diving. In diving, three (3) divers will qualify at each of eight regional meets.

Relay entries to the UIL State Meet should be in the UIL office 10 days prior to the start of the meet. No entry sheets need to be sent to the UIL for the state meet, only indicate your relays online. If you are scratching a swimmer or relay after you have left the Region Meet site, contact the Region Meet Director and the UIL with that information. It is your responsibility to get any information to the UIL office they request. Check their website for your responsibilities.

Meet

Committee: The Meet Committee will consist of the Meet Director, Meet Referee, one female from District 21, one coach from District 22, one coach from District 23, and one male athlete from District 24 in attendance.

Weather Contingency

Plan: In the unlikely event that a session(s) needs to be postponed, the corresponding events and times will be moved to the first available day, working in conjunction with CFISD Aquatics staff.

OFFICIALS: Swimming and Diving

As per UIL regulations all deck officials must be currently registered with UIL / NFHS.

If you have officials that would like to work the meet, please have them contact the **Meet Referee Rob Morris** by email (robert.c.morris@gmail.com) and have them provide the following information in their email:

- ❖ School district and school you are representing (if any),
- ❖ Number of years you have been a high school official and if you are a USA Swimming certified official.

Officials will be contacted if you have been selected to work the meet

Officials will need to attend a mandatory meeting one hour before each session at 4:30p in the hospitality room.

- **The uniform for preliminary session will be white polo shirt over khaki pants/skirt with all white tennis shoes** (NO hats).
- **Finals uniform will be navy blue polo shirt over khaki pants/skirt with all white tennis shoes** (NO shorts or hats).

TIMERS: Kingwood HS will provide most timers for both Prelims and Finals Sessions. There will be a SignUp Genius link in the parent information document that will come out the week of the meet if any timing slots are available and parents want to time.

ELECTRONIC RECORDING: Any electronic recording will be permitted in the spectator area (see All American Diving exception). Videotape or film will not be used in judging any swimming/diving event. Please be sensitive to the other spectators. No strobe or artificial lights may be used.

DIVING: Schools may appoint one individual to film/ videotape the diving competition. This person will receive a media pass the morning of the diving competition that will give them access to the pool deck.

SWIM: There is no flash photography of any kind, parents or media, allowed at the start of a race. The credentialed media must wear the deck pass always while on deck. There is absolutely no photography from behind the starting blocks at any time. Failing to observe these conditions may result in your pass being revoked.

RULES:

As guests of the aquatic facilities all must adhere to the CFISD Natatorium rules.

- Coaches must supervise their swimmers/ divers at all times.
- Locks may not be left on lockers overnight.
- Children must be supervised at all times and are not allowed on the deck.
- The Natatorium is on school property and all participants/guests/visitors must adhere to District's policies and regulations.
