ENTRY FEES

NOTES TO DISTRICT MEET DIRECTORS

- <u>Area/District Meet Director must certify any scratches and/or additions.</u> The coach scratching an athlete should contact the Area Director, and the next place coach. The Area Director should verify with the next place coach if that athlete will indeed participate. Once verified, the <u>Area Director</u> should contact the Clear Creek ISD Athletic Office (281-284-2845). Please submit the same information submitted via email to: jgrier@ccisd.net
- We will then scratch and add the appropriate athlete <u>based off the Area Meet Director's</u> <u>email.</u>

TEAM PARKING, ENTRANCE & SET-UP

- Challenger Columbia Stadium is located on West NASA Blvd off of I 45 & Nasa Rd 1 (see map) Exit 25
- Buses will park in the SE parking lot of Challenger Columbia Stadium. (Visitor's Side)
- Participants will enter through the Southeast entry gate. Participants must have their number on to enter free.
- Each competing team will receive 5 wristbands for coaches and/or trainers.
- Coaches traveling separate from their team and athletes traveling with their parents will need their participant's number/wristband prior to entering the parking lot.
- NO PASSES WILL BE ACCEPTED
- Tents for teams on the visitor's side, inside the stadium seating, must be set-up on the upper deck of seats.
- Team camps will be on the east side (visitor) stands and concourse.
- No Team camps on the Grass inside the stadium.
- No team camps will be allowed in the west side (home) stands as this will be for spectators only.
- The fieldhouse will be off limits to ALL COACHES, ATHLETES & SPECTATORS. There will not be a coaches hospitality room.
- THE BALCONY OF THE FIELDHOUSE IS RESERVED FOR AUTHORIZED PERSONNEL ONLY!!

There will be CONSESSIONS SOLD – ON THE HOME SIDE ONLY!!! Teams may bring snacks and drinks!!! Food and drinks will not be allowed inside the stadium!

DAILY ADMISSION CHARGE Entrance Gate 1

ONLINE ONLY @ Gofan.co \$10.00 per day PER PERSON. Wristbands will be given as you enter the parking lot. The visitor's side is for athletes only; all spectators are required to sit on the home side and outside the fencing of the field events area.

UIL MEET RULES

- The first and second place finishers in each event qualify for the state meet.
- Coaches will not be allowed on the track. There will be a designated coach's area for field events.
- Contestants must report on time to be entered in any event. Any contestant who fails for any
 reason to be on hand at the time of the preliminaries shall forfeit the right to compete in the
 preliminaries and finals of that event. (UIL Plan Section 1320-J)
- No excuse will be accepted for failure of a team or contestant to appear at the announced reporting time.
- Lane Assignment will be random within each heat/Standard Lanes for Finals.

ATHLETE CHECK IN

- When athletes present themselves to the clerk for check-in they must be, "run ready".
- Complete uniform must be on their body with number attached to their uniform top.
- Relay team uniforms (shirt and shorts) must be identical.
- Challenger Columbia Stadium track is a Beynon polyurethane pour system. Spike length is limited to 1/4". Tape/Chalk is <u>NOT</u> allowed on the track surface. Relay markers will be provided at each exchange.

Wheelchair Division

- Please notify Jimmy Grier, jgrier@ccisd.net, prior to the meet that you will have Wheelchair Athletes trying to qualify for state.
- These athletes are competing for FAT qualifying times.
- Students in wheelchairs will be able to participate in the wheelchair division of the 100-meter dash, 400-meter dash and shot put. These events will be non-scoring and the participants have qualified by submitting a qualifying mark of performance. The 100 and 400 meter dash will go at the end of each event and the shot put will follow at the conclusion of each division

VIDEO TAPING

Athletes and coaches may utilize electronic devices to aid in the athlete's performance.
 Usage of such devices may not slow down or interfere with the normal flow of the meet.

IMPLEMENT WEIGH-IN

- Implement weigh-in/check-in will begin 90 minutes prior to the start of each throwing event and will be in the metal building beside the field event center. All implements will be impounded and brought to the competition area.
 - Weigh-in will close 45 minutes prior to each throwing event.
- Upon completion of each throwing event, implements will be immediately brought back to the weigh in area where they may be picked up.

DISCUS SECTOR

 The National Federation rule has required the use of a 34.92-degree sector in the shot put and discus. The 34.92-degree sector will be used at the state meet and we will use a 34.92-degree sector at the Region III Meet.

POLE VAULT CHECK AND VAULTER WEIGH IN

- As per National Federation rules, the competitors' weight shall be at or below the manufacturer's pole rating with a 1" circular band indicating the maximum top hand hold position.
- Per UIL instructions, all pole-vaulters must weigh in before competition. The
 designated official will begin weigh in 90 minutes prior to competition. Weigh in will
 close 20 minutes prior to competition time. It is the Coaches responsibility to present
 this verification form to the officials prior to competition, to ensure the athletes are
 competing on the appropriate pole for their weight.
- Weigh in will be in the visitor's training room on the Team Camp side, under the balcony.

ACCESS TO THE TRACK

 Officials will escort competitors to the track prior to each race, as well as to the exit gate upon completion of each race. Access will be allowed only through the clerking area under the scoreboard. Athlete's MUST check in with the clerk in the clerking area before they will be allowed on the track or infield.

PROTESTS

• Protests must be lodged in writing to the designated official within thirty minutes of the results being posted. The designee will notify the referee.

PROPOSED OPENING HEIGHTS AND INCREMENTS

- The Pole Vault will progress at 6" increments. The High Jump will progress at 2" increments.
- When four jumpers are left, the pole vault will progress at 3" increments. The high jump will progress in 1" increments
- Opening heights will be announced at the technical meeting based on entries.

HORIZONTAL & VERTICAL JUMPS:

- Ties in High Jump and Pole Vault any tie that involves places 1st 6th will be required to compete in a tie breaker. All tie breakers will take place once the competition is completed (it is the responsibility of the athletes and coaches to be present, an announcement will be made once the competition is completed).
- Long Jump, Triple Jump and Pole Vault athletes are not permitted to run backwards on the runway before, during or after the competition.

SEEDING/LANE ASSIGNMENTS;

• Heats will be seeded according to Area times, but lanes will be random within the heats, Finals will be seeded based on prelim times-standard lanes

RELAY PRACTICE TIME

The track will be open at the following times for **relay practice ONLY**:

- Friday 10:00 AM 11:00 PM 6A ONLY; 2:00 PM 3:00 PM 5A ONLY
- Saturday 1:30 PM 2:30 PM All Relays
