SPRING 2017 REFERENDUM BALLOT

BALLOT ITEM #1

FOR CONFERENCE 5A ONLY - Currently in football only, Conference 5A is split into divisions after the regular season. All of the schools in the conference are placed into 32 districts for the two-year alignment period. After district competition, the playoff teams are separated into divisions with the top two highest enrollment teams from each district going into Division I and the two lowest enrollment teams from each district going into Division II.

If approved, this referendum ballot rule change would split Conference 5A into Division I and Division II prior to the alignment release, as is currently done in Conferences 1A-4A.

In Conferences 1A-4A, the schools in each of these conferences are divided into two divisions based on enrollment with the largest half being placed in Division I, and the smallest half being placed in Division II. Schools in a division are then placed into 16 districts for the two-year alignment period. The top four finishers from each district advance to post-season for Conferences 2A-4A.

In Conference 5A (Football only), would you be in favor of a rule change that would split the Division I and Division II conferences (split conference alignment as is currently done in Conferences 1A-4A) prior to the alignment release?

BALLOT ITEM #2

FOR ALL CONFERENCES - In Spring 2011, UIL school superintendents were surveyed regarding reducing the number of tournaments/meets for various UIL sports. The survey results lead to the UIL Legislative Council reducing one (1) tournament/meet from team and individual sports (not including football WHICH DOES NOT INCLUDE TOURNAMENTS).

Restoring the tournament in team sports would return the total allowable tournaments students may participate in to three (3). Team sports include: volleyball, basketball, soccer, softball and baseball.

Restoring the meet in individual sports would return the total allowable meets students may participate in to eight (8). Individual sports include: cross country, swimming and diving, track & field, golf, tennis and wrestling.
