Over the past ten years, participation in Computer Applications has steadily declined. Factors cited by school personnel as contributing to low participation include: lack of student interest, difficulty finding teachers to coach the event, school districts adopting technology that is not compatible with the contest (such as Chromebooks and Google Suite), and business competition opportunities with other organizations that are more applicable to courses being taught.
