EVIDENTIARY HEARINGS AND OPEN MEETINGS (AA-GG)

At the close of arguments, the Committee may go into closed deliberations if all persons present and having rights under the Texas Open Meeting Act, Article 6252-17, Vernon's Annotated Civil statutes, agree to waive their rights. In such closed deliberations, no person other than Board members who are not involved in the cases may be present. If any person makes a timely objection under the Texas Open Meetings Act to closed deliberations, the Board's deliberations will remain open to the public.
